

PROJECT SUPERINTENDENT

- Maintain a safe and organized office and jobsite.
- Review of shop drawings and coordinate between project drawings and specifications.
- Coordinate contractor activities through verbal and written communication, including meetings and the use
 of project schedules.
- Responsible for all safety aspects on an assigned project including OSHA requirements, promoting, and encouraging safe work practices and immediate correction of job site hazards.
- Maintain a high level of quality control.
